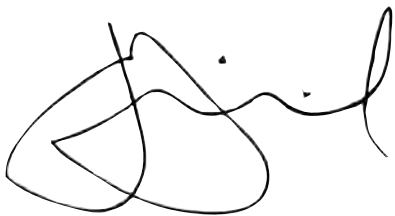

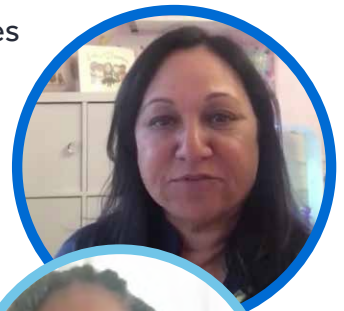
Strengthening Diversity

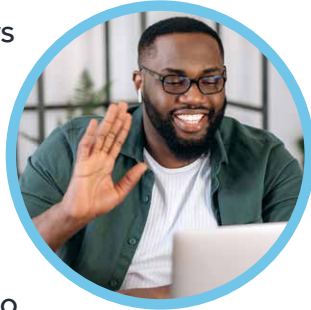

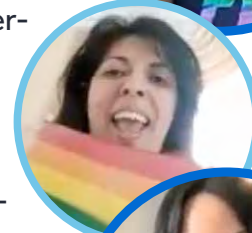
Trusted Advisors

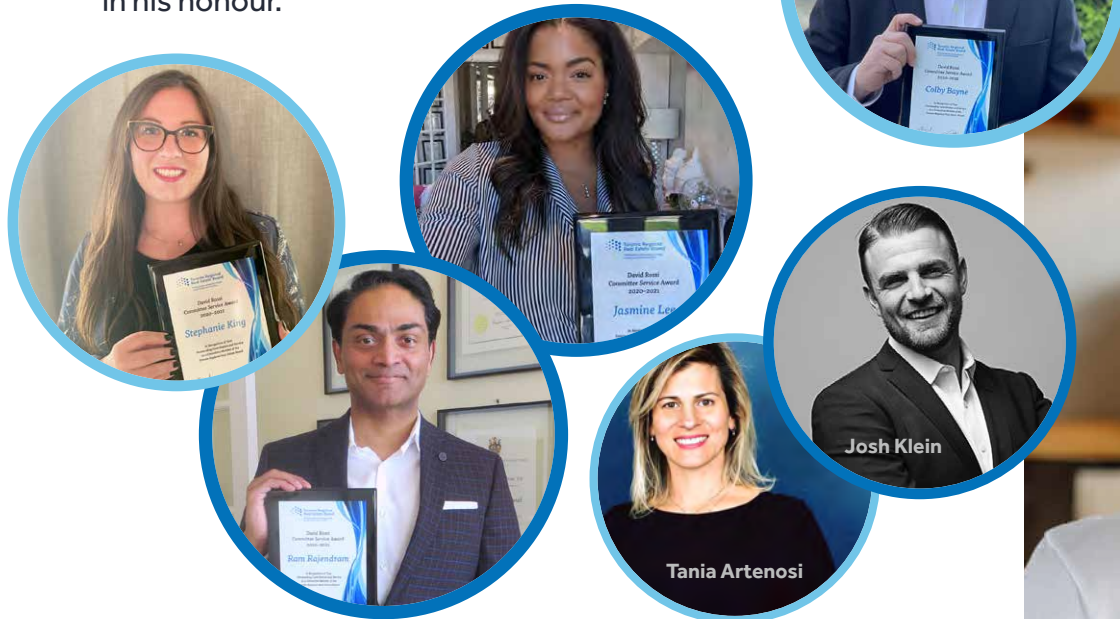
Awarding Dedication and Commitment
